

CALL FOR PARTNERSHIP (LICENCE)

PROVISION OF VENDING MACHINES OR UN-MANNED SOLUTIONS FOR THE SALE OF SPORTS MERCHANDISE AT ACTIVESG FACILITIES

Agreement period: To commence by Dec 2023/Jan 2024

2 years licence period with the option to extend by 1 additional year at the discretion of SportSG



BACKGROUND ON ACTIVESG



- ActiveSG is an all-inclusive national movement for sports, by Sport Singapore (SportSG).
- A lifestyle destination for Singaporeans to live better through sports, with facilities island-wide and member privileges offered to all ages and abilities (refer to page 5 for a full list of locations).
- Today, ActiveSG serves over 2 million users across Singapore, with a reach of various segments within the community.
- Members range from all age groups, with the majority being working adults aged twenty (20) to fifty-nine (59).











OBJECTIVES OF PARTNERSHIP (LICENCE)



- 1. To enhance visitors' experience at ActiveSG Sport Centres by providing convenience and accessibility.
- 2. This call for partnership aims to source for vendors in the market who would be interested to work with us and contribute to the sports community, through sale of the non-exhaustive list of products* stated below:
- **Gym towel** (required to be sold at all locations, no higher than Retail Selling Price of \$2.50)
- **Sport apparels** i.e. swim wear (goggles, swimming cap, swim shorts, rashguard), gym socks, footwears, performance enhancing gears (sweatband, resistance bands, ankle/wrist/knee guards, swim paddles, kickboard, pull buoy)
- Sport equipment i.e. racket grips, shuttlecock, ping pong balls, tennis balls
- Toiletries/ Personal Care i.e. shampoo, body wash, deodorant, sunscreen, wet wipes, tissue
- Energy Supplements i.e. energy bars (excluding any form of beverage)
- 3. Other possible opportunities outside the abovementioned scope may include Event Partnership (including but not limited to co-branding opportunities with sports and lifestyle angle).

- Fixed Model Monthly fixed licence fee paid to SportSG; or
- · Variable Model Monthly commission sharing of total gross sale; or
- Hybrid Model Combination of both fixed and variable approaches

4. Service standards to be expected

- No. of customer support channels
- Frequency of stock replenishment
- Customer service response time
- · Frequency of maintenance
- Repair turnaround time

TERMS OF PARTNERSHIP (LICENCE)



- · Only cashless payment modes to be accepted.
- Price of product(s) to remain constant throughout the duration of the agreement, unless prior notice to SportSG is given.
- To ensure constant supply of gym towels in the vending machines at all times.
- To ensure that machines are always operating at optimum professional standards, with all necessary authorities' approval standards, and to undertake the purchase of insurance required to operate the intended business at SportSG facilities in case of claims arising from consuming/use of products etc.
- To provide monthly sales report with detailed breakdown and annual audited report* that has been cross-checked with settlement reports, to ensure accuracy of billing.
- To undertake all costs of installation, of which includes (but not limited to) deployment on the ground, timely maintenance, servicing, and any other miscellaneous costs.
- Vendor shall also bear the cost and/or responsibility resulting from unforeseen circumstances, such as system error causing incorrect pricing charges, service recovery, or any unforeseen accidents.
- Awarded partner(s)+ will be required to pay a Security Deposit (3 months' worth of maximum projected revenue), to be held by SportSG, regardless the type of revenue model.
- At least 3 months' notice in writing for any termination of agreement.
