

## TERMS AND CONDITIONS

OF

SPORT SINGAPORE'S

GET ACTIVE! SINGAPORE 2022 SURVEY

SHARE YOUR FEEDBACK AND STAND TO WIN COOL PRIZES  
(THE "LUCKY DRAW")

BY PARTICIPATING IN THIS LUCKY DRAW YOU HEREBY CONFIRM THAT YOU HAVE READ, UNDERSTOOD AND AGREED TO BE BOUND BY THE FOLLOWING TERMS AND CONDITIONS.

### 1. The Organiser

- 1.1 The "GET ACTIVE! SINGAPORE 2022 SURVEY, SHARE YOUR FEEDBACK AND STAND TO WIN COOL PRIZES" (the "Lucky Draw") is organized by the Singapore Sports Council (rebranded as "Sport Singapore with effect from 1 April 2014 and hereinafter referred to as "SPORTSG") of 3 Stadium Drive, Singapore 397630.

### 2. Eligibility

The Lucky Draw is open to all Singapore citizens and permanent residents (except for SPORTSG's employees).

### 3. Duration of Get Active Singapore 2022 Survey & Lucky Draw

- 3.1 The survey shall run from 23 July 2022 ("Start Date"), Singapore time (GMT +1000) to 31 August 2022 ("End Date"), Singapore time (GMT +0800), the "Survey Period".
- 3.2 The Lucky Draw shall be held at SPORTSG's office on 12 September 2022.
- 3.3 Only entries submitted during the Survey Period as specified in Clause 3.1 above shall qualify for the Lucky Draw.

### 4. How to Participate

- 4.1 To participate in the Lucky Draw, you must:
- Access the Get Active! Singapore 2022 Survey via the QR codes or web links and complete the survey; and
  - provide your name and either email or mobile phone numbers at the end of the survey.
- 4.2 Each person is entitled to one (1) survey submission and entitled to win one (1) prize in the Lucky Draw.

## 5. Entry Requirements/Criteria

- 5.1 Your entry must be submitted with your name and either email or mobile phone numbers at the end of the survey. SPORTSG reserves the right to disqualify any participant whose entry is discovered not to fulfill these criteria. In such event the participant shall be liable to SPORTSG for any damages, losses, costs or expenses it may suffer or incur as a result thereof including but not limited to the return of any prizes awarded in this Lucky Draw or its monetary equivalent.
- 5.2 Any incomplete entry and/or any incomplete or insufficient submission of personal details may, at SPORTSG's sole and absolute discretion, result in the disqualification of the entry from the **"GET ACTIVE! SINGAPORE 2022 SURVEY"**. You warrant by your participation in the Lucky Draw that the information, details and particulars submitted by you to SPORTSG are true, accurate and complete.
- 5.3 SPORTSG shall not be liable for any incomplete, lost, late, damaged, illegible or misdirected entries for any reason whatsoever and shall not entertain nor be liable for any claims whatsoever in respect of whether a particular entry from you was duly received and/or accepted for participation in the Lucky Draw.
- 5.4 Any entry that fails to meet any requirements stipulated in these terms and conditions shall be disqualified. No appeals against such disqualification shall be entertained.

## 6. Lucky Draw Winning Entries

- 6.1. Subject to clause 6.2, thirty (30) winners of the Lucky Draw will be selected through the random digit generator in Excel. The winners will be contacted via email / sms after the draw period.
- 6.2. SPORTSG reserves the right to substitute any winner upon disqualification. SPORTSG also reserves the right, at its sole and absolute discretion, to determine if there will be no, or fewer, winners and to distribute the prizes as it sees fit.

## 7. Lucky Draw Winner Notification and Collection of Prizes

- 7.1 Winners will be notified via sms/email from 12 September 2022 onwards. SPORTSG shall not be liable for late, lost, misdirected or unsuccessful efforts to contact and notify the prize winner.
- 7.2 Prizes are to be collected from SPORTSG's offices by the winners in person. Lucky Draw prizes not claimed after 2 months shall, at the sole and absolute discretion of SPORTSG, either be forfeited, withdrawn or given to new winner(s) which shall be determined by a re-draw.
- 7.3 Proof of identity must also be provided at the point of collection. No right to compensation shall accrue nor be given to the winner if he/she fails to provide proof of identity as well as his/her relevant Personal Details accurately to SPORTSG at the point of collection or fails to claim the prize in accordance with the collection instructions provided in the notification.

## 8. Prizes

### Lucky Draw

- 8.1 There will be a total of **30 prizes**, and the details are as follows:
  - a. Decathlon \$50 Gift Cards (maximum of 30 winners)

The winners of the Lucky Draw shall adhere to the Terms and Conditions herein. Failing which, the winner(s) of the Lucky Draw shall be liable to SPORTSG for the reimbursement of the monetary equivalent of the Lucky Draw Prize.

#### General

- 8.2 All prizes are non-transferable, non-refundable and non-exchangeable for cash or credit, and are subject to any terms and conditions as may be imposed by the merchant, service provider or supplier of the prizes, if any. SPORTSG shall not be liable for any variation in the prizes or prize values.
- 8.3 Notwithstanding anything in these terms and conditions to the contrary and without prejudice to this clause, SPORTSG reserves the right at any time and at its sole and absolute discretion, to substitute, withdraw or cancel any prize or make changes to the value and/or number of the prizes at any time without prior notice and without having to disclose any reason therefore and without any payment or compensation whatsoever in lieu thereof.
- 8.4 All ancillary costs and expenses, duties, value added taxes or tax liability incurred by the winner as a result of winning or otherwise in connection with the prize, shall be the sole responsibility of the winner. SPORTSG shall not be liable for any taxes (including but not limited to income tax), costs, expenses or duties that may arise from the winning of or otherwise in connection with the prize. Please also take note of the local laws and regulations which may govern the issuance or receipt of or otherwise in connection with the prize.
- 8.5 Without prejudice to this clause, to the fullest extent permitted by law, SPORTSG excludes all liability for any loss or damage whatsoever suffered (including, without limitation, indirect or consequential loss), or for personal injury suffered or sustained in connection with the Lucky Draw or as a result of issuance, receipt and use of, or otherwise in connection with any of the prizes.

### **9. Participant's warranties and undertakings**

By participating you represent, warrant, undertake, agree and/or acknowledge that:

- a. the information, details and particulars submitted by you to SPORTSG are true, accurate and complete. Any incomplete entry (including failure to furnish any required details) may be disqualified from the Lucky Draw at SPORTSG's sole and absolute discretion;
- b. each entry that you submit should be made strictly in accordance with these terms and conditions – otherwise, such entry may be disqualified, at the sole and absolute discretion of SPORTSG; and
- c. you have read and understood, and thereby agree to all the terms and conditions of participation in the Lucky Draw as set out herein, including all amendments, additions, replacements and modifications hereto as may from time to time be made by SPORTSG. SPORTSG shall notify participants and the public of such Amendments by a notification to be posted on the organisation Website.

### **10. Miscellaneous**

#### Personal Details

- 10.1 SPORTSG collects your personal details in order to conduct the Lucky Draw, and may pass that information to its related bodies, corporations and agencies assisting with the Lucky Draw.

- 10.2 By participating in the Lucky Draw, you consent to the public disclosure of your Personal Details including your name, your photo and/or your entry for publicity purposes of SPORTSG in relation to the Lucky Draw.

*Lucky Draw Fitness and Variation*

- 10.3 The Lucky Draw Period may be extended or shortened at SPORTSG's sole and absolute discretion.
- 10.4 SPORTSG reserves the right to disqualify – at its sole and absolute discretion, any entry which it deems inappropriate and to not allow the entry to be drawn during the draw periods. In the event of the aforesaid disqualification, no explanation will be provided by SPORTSG.
- 10.5 Without prejudice to other clauses hereto enabling SPORTSG to disqualify any entry, SPORTSG reserves the right to declare any entry void and to modify the Lucky Draw details or any part thereof or to cancel the entire Lucky Draw at any time during the Draw Periods due to unforeseen circumstances,
- 10.6 Notwithstanding anything in these terms and conditions, SPORTSG reserves the right at any time and at its sole and absolute discretion to determine and/or amend, by addition to, deletion from or variation of, these terms and conditions without prior notification, including but not limited to the terms and conditions concerning the eligibility for the Lucky Draw, criteria for the Lucky Draw and the selection of winners.

*Liability and indemnity*

- 10.7 SPORTSG and its associated sponsors, if any, shall not be liable for any incomplete, lost, late, damaged, illegible or misdirected Entries for any reason whatsoever, or any combination thereof.
- 10.8 You (including your heirs, executor and/or administrators) hereby agree to indemnify fully and hold SPORTSG and its directors, officers, employees, and assignees or any other associated sponsors thereof (the "**Indemnified Parties**") harmless from and against any and all claims, losses, liability or damages (including but not limited to economic loss, damage to any property or injury to or death of any person and any legal costs) that may be suffered or incurred by any of the Indemnified Parties arising whether directly or indirectly from:
- a. any negligent act or omission or willful default, misconduct or fraud by you; or
  - b. any action, claim, loss, damage, cost and expense whatsoever brought against, suffered or incurred arising from or in connection with any breach of the terms and conditions hereunder (including, without limitation to the generality of the foregoing, a breach of the representations, warranties, undertakings, agreements or acknowledgements hereof) by you.

10.9 Neither SPORTSG nor SPORTSG's employees, affiliates, representative offices, authorized agencies or any other associated sponsors associated with the Lucky Draw shall be held liable for any failure or omission to carry out the Lucky Draw in accordance with these terms and conditions or for any loss or damage suffered by you in relation to the Lucky Draw or your participation therein, including where such failure, omission, loss or damage arises out of or in connection with any event of force majeure, including without limitation any calamity or conditions, Acts of God, war or warlike hostilities, civil commotion, riots, blockades, embargoes, sabotages, strikes, fires, lockouts, shortages of material or labor, terrorist activity, epidemic, quarantine restrictions, health risk or any defect, failure, or any other occurrence beyond the reasonable control of SPORTSG, SPORTSG's employees, affiliates, representative offices, authorized agencies or any sponsor associated with the Lucky Draw, as the case may be.

Others

10.10 Information on how to enter the Lucky Draw and on the prizes via the survey links shall form part of these terms and conditions governing the Lucky Draw.

10.11 SPORTSG's decisions in all matters related to the Lucky Draw, shall be final and binding.

10.12 In the event of any inconsistency between these terms and conditions and any brochures, marketing or other promotional materials or communications relating to the Lucky Draw, these terms and conditions shall prevail.

10.13 The Lucky Draw and these terms and conditions shall be governed by and construed in accordance with the laws of Singapore, and by participating, you submit to the exclusive jurisdiction of the Courts of the Republic of Singapore.
