# GET ACTIVE! SINGAPORE PESTA SUKAN 2025 SINGAPORE URBAN WALK CHALLENGE

#### Rules & Regulations

- 1. Singapore Urban Walk Challenge ("Event") is organised by ActiveSG ("Organisers") in accordance with these Rules and Regulations ("R&R") applicable to the registered participants ("Participant(s)").
- 2. Details of the Event, including Event date, registration information and fees can be found on the "Official Website".
- 3. Participant(s) must register for the event through the Official Website by the stipulated closing date ("Closing Date"). Registration after the Closing Date and up till the Event Day itself will not be accepted.
- 4. The Event has the following categories:

Category	Age Group	Registration fees
Individual	15 years old – 54 years old	\$15 / participant
Individual (Masters)	55 years old & above	\$5 / participant
Corporate Challenge	10 participants in a team - minimum aga is 15 years old and above	\$150 / team


5. This event is not a time-based competition with no timing system to be issued. Participants must complete the entire route by foot within 14 and half hours from the start time.

# **Event Information**

- 1. Title: Singapore Urban Walk Challenge
- 2. Date: 2<sup>nd</sup> August 2025 (Saturday)
- 3. Start and End Point: Singapore Sports Hub, OCBC Square, Visitor Centre
- 4. Format: By foot, walk, jogging (no cycling or use of PMDs)
- 5. Event Duration: 700am to 930pm (Cut off time at 930pm)
- 6. Registration open time: 630am (at Visitor Centre)
- 7. Start time: Between 700am to 8.30am at Singapore Sports Hub, OCBC Square (side of Visitor Centre)
- 8. Check Points (to be finalised): Participants to Check in via the QR Code located at the Checkpoint.

## **Registration**



- 1. All participants must register for the Event via the ActiveSG website.
- 2. Payment of the registration fees will be made via the ActiveSG website.
- 3. Once the registration form and payment have been submitted, participants will receive the confirmation receipt immediately.
- 4. Registration for the Event will only be confirmed after the Organisers receive the correct payment.
- 5. In event that the Participant did not receive the confirmation email 7 working days after submitting the registration, the Participant can contact the Organisers.
- 6. In participating in the Event, the Participant agrees to:
  - (i) provide true, accurate, current and complete information about the Participant contained in the registration form (the "Registration Data");
  - (ii) maintain the security of the Participant's password and identification; and
  - (iii) maintain and promptly update the Registration Data to keep it true, accurate, current and complete. Otherwise, the Organisers may suspend or terminate the Participant's registration.
- 7. The Organisers reserve the right to contact and to interview the Participant for additional information required for matters relating to this Event.
- 8. The Organisers may contact the Participant from time to time by email and/or through the provided contact number. Any notice sent to the email address or messages sent

- to the mobile phone registered with the Organisers shall be deemed as received by the Participant.
- 9. Completion of the online registration form confirms the Participant's agreement to abide by these R&R of the Event.

#### General

- 1. The Organisers reserve the right to modify or substitute any of these R&R from time to time as it deems fit. If there is ambiguity in any of these provisions, the Organisers shall be the authority to interpret and in so doing, they will take into account the interest of the affected Participant. Any amendments to these R&R will be updated on the Official Website
- 2. The Organisers reserve the right to use any photographs (including those of the Participant), motion pictures, recordings, or any other media records of the Event, for any legitimate purpose, including commercial advertising.
- 3. All Participants must be at the designated start point 30 minutes before the start of the Event.
- 4. All Participants must be self-sufficient and responsible for his/her own equipment including but not limited to water, food and gear for walking.
- 5. Participant must respect the environment and use the waste and recycling bins along the route or at the checkpoints.
- 6. No pets, bicycles, in-line skates, prams, push carts, shoes with built-in or attached rollers, or any forms of Personal Mobility Device shall be used in any part of the Event.

### **Age Requirements**

1. Participant's age at the point of registration is from 15 (by date of birth) and above.

### **Cut Off Times for the Event**

- 1. Participants who are unlikely to reach a checkpoint or end point within the stipulated cut-off times ("Cut-off Times") as indicated on the Official Website will NOT be disqualified from the Event.
- 2. Cut-off timing for participants to reach the End Point is 9.30pm at Singapore Sports Hub
- 3. At every checkpoint, every Participant must scan a QR Code (FORMSG) to indicate that he/she has reached the checkpoint. The check-in time of each Participant will be recorded.

### **Finisher Entitlement and Medals**

- 1. Finisher Medals will be awarded to all participants who have completed all checkpoints within the stipulated time.
- 2. An event towel will be issued to all participants who have completed all checkpoints at Sport Hub final point (while stock last).

#### **Health and Safety**

- 1. There will be no road closure throughout the Event to minimise disturbance to the public. Therefore, for safety reasons and to prevent dis-amenities, Participant is reminded to abide by traffic rules and rules stipulated by NParks and by any venue used by the Event. The Organisers shall not be responsible for any wilful behaviour such as jaywalking or any acts that endanger or cause any inconvenience to fellow road and park users. (Please refer to the Parks and Trees Act on NParks website, as well as "Pedestrian Road Safety" on Singapore Road Safety Council website).
- 2. Whilst reasonable precaution will be taken by the Organisers to ensure the Participant's safety, the Participant acknowledges that he/she takes part in the Event at his/her own risk and the Organisers will not be responsible or held liable for any injury or death howsoever arising from training for or participating in the Event.
- 3. Each Participant is responsible for his/her own safety throughout the Event and agrees to the indemnity conditions upon submission of registration.
- 4. The Participant is strongly encouraged to consult his/her medical practitioner prior to registration and before the actual Event.
- 5. The Organisers shall not be liable for any loss and/or damage, whether personal or otherwise, and howsoever arising.
- 6. The Participant must retire from the Event immediately if required to do so by any member of the official medical staff, Organisers or checkpoint ICs.
- 7. Participant should walk on the designated path for the entire route and observe traffic flow.
- 8. Each Participant must carry and wear appropriate clothing during the Event. As the Event stretches into the night, every Participant must dress appropriately so as to remain visible to other road users. Head torch, flashing lights, reflective wear, etc are highly encouraged.

### **Cancellation and Amendments**

- 1. There will be no refund of any fees paid if the Event is cancelled due to unforeseen circumstances. These include but are not limited to General, Election, bad weather, NEA advisory against outdoor activities, or any other advisories relating to the safety of the Participants.
- 2. The Organisers reserve the right to cancel the Event at any time without prior notice to the Participant, in which case they will make reasonable effort to inform the Participant prior to the Event.
- 3. The Organisers reserve the right to amend the Event walking routes as they deem fit for the safety of the Participant and/or to prevent any potential hazards at any time without prior notice to the Participant. In such cases, every effort will be made to inform the Participant prior to the day/date of the Event. The Organisers shall not be liable for any other loss or inconvenience caused due to such changes.

# **Use of Personal** Data

- 1. The Participant, who has registered to take part in the Event, is deemed to have given written permission to the Organisers to collect, analyse and collate any personal information relating to that Participant, as the Organisers may at their sole discretion deem fit, for the Organisers' programmes, planning, data-processing, statistical or risk-analysis, research, fund-raising and/or, any other purposes defined by the Organisers.
- 2. All the Participant data will never be sold or exchanged. ActiveSG will only use it to share news and information about ActiveSG's updates and events, including future editions of Urban Walk Challenge.
