

### **ActiveSG Sport Interest Groups**

## Rules and Regulations

### 1. Purpose

- (a) The purpose of an ActiveSG Sport Interest Groups (the "**Programme**") is to promote the sport for which the relevant interest group is established through.
- (b) The Programme is organised by ActiveSG, a division in SportSG.

# 2. Registration

- (a) The Programme is open to everyone registered with ActiveSG.
- (b) For participants aged below 18 years, it is mandatory to obtain the consent of parent/guardian before participating in this Programme.
- (c) Age of participants are determined at the time of registration. Senior Citizens are persons aged 55 years and above. Students are persons enrolled as full time students with a valid student card. Identification documents may be required for verification purposes.
- (d) Participants are allowed to register 15 days in advance before the commencement of the 1<sup>st</sup> session of the programme and on a first come, first served basis.
- (e) Participants must register and make payment for the Programme via MyActiveSG+. Counter registration will be discontinued to ensure fairness. For participants who require one-off assistance, please approach any of our ActiveSG staff.
- (f) Participants may book only one slot per session. Multiple table bookings within the same time slot are not permitted.

#### 3. Schedule of Booking Session

- (a) Schedule of interest group might be subject to change due to the availability of the respective venue.
- (b) In the event of another ActiveSG programme happening on the date of scheduled session, the ActiveSG programme will take precedence and a replacement session will be arranged for the interest group.

## 4. Group sizes for each sport

Sport	Group size per court /table
Badminton Pickleball Tennis	Max 8 person (min. of 6 persons required to start a group)
Table Tennis Squash	Max of 5 person (min. of 4 persons required to start a group)
TTX	Max of 50 pax (min. of 4 persons required to start a group)
Basketball Volleyball	Max 20 person (min. of 12 persons required to start a group)

## 5. Management of the Interest Group

- (a) A group leader will be appointed by ActiveSG.
- (b) The management of the activities of the interest group shall be the responsibility of the group leader.
- (c) The group leader shall ensure that all members of the interest group have a fair share of playing time.
- (d) The group leader shall ensure new members are accepted in the interest group at all times.
- (e) The group leader will work directly with ActiveSG to assist, contribute and organise activities for the participants of the interest group.
- (f) The group leader shall ensure that all information pertaining to the interest group are disseminated to the team members.

## 6. Player Attire/Equipment

- (a) Proper sporting attire should be worn at all times. No marking shoes will be allowed in the Sport Hall.
- (b) Participants with inappropriate behaviour shall be removed from the interest group.
- (c) No sport equipment, save for table tennis equipment, will not be provided. Participants are to bring their own sport equipment. Should a participant require table tennis equipment, he/she shall request for the equipment from guest service reception at the respective ActiveSG sport centre, and return the equipment after the session. The participant shall take care to ensure that the equipment is not damaged during his/her usage. In the event that damage is caused during the session, the participant may be required to pay for any and all costs related to any repair or replacement of such damaged equipment

### 7. Safety

- (a) All participants of interest groups for outdoor sport should at all times abide by the rules of Lightning Warning System (LWS).
- (b) In the event where the LWS is activated before the start of the session, a replacement session will be arranged. However, if the LWS is sounded during the session, no replacement session will be arranged.

#### 8. Interest Group Jurisdiction

- (a) All participants are to respect and abide by the instructions of SportSG staff at all times.
- (b) SportSG shall not be responsible for or be liable for any death, disability, personal injury, loss of property or any other losses during the course of the Program.
- (c) SportSG reserves the right to amend these Rules and Regulations at any time without prior notice.
