Competition Matters

-
- Open Team Format:
 - Consists of 3 matches
 - 1 Singles and 2 Doubles
 - At least 5 players, maximum 6 players
 - **Maximum 1 non-SC/PR** player per team
 - **Mandatory 1 female player** per team
 - Players are **not allowed to repeat.**
 - Mandatory to field at least one female player in the **1st Doubles Open [1]** or **Singles Open [2]** match in the Team Line Up.
 - Female player **must be present to play her match** if not the team shall **concede the entire team match**

Competition Matters

-
- Team Event Format:
 - All matches to be played in Stage 1
 - All matches in Stage 1 is best of 5 games
 - Top 2 teams from each group to progress to Stage 2 for single elimination

Competition Matters

-
- Team Event Format:
 - Stage 2, match will end when:
 - Open Team: one team won 2 matches
 - All matches in Stage 2 is best of 5 games
 - Umpire will be provided from Quarter Finals onwards
 - **Finals will be held at OCBC Arena, 4th August (Sunday)**

Competition Matters

-
- Attire
 - Players are required to **wear same attire as a team/pair** for their matches
 - Prize Money and Medals
 - Prize money and medals will be given to **top 3 positions (Joint 3rd)**
 - All prize winners **MUST** be present at the ceremony in neat attire (**No singlets, slippers and sandals**)

Competition Matters

-
- Team Line Up
 - Lineup will be filled in order of the team registration list if not submitted 5 minutes before scheduled match time
 - WALKOVER
 - If player for individual match did not report at scheduled time

Competition Matters

- SUPPLEMENTARY RULE

- Players are to produce their IC/Student Card for registration

Competition Matters

- DISPUTE

- In the event of any dispute, the match shall be played under protest.
- The OC shall determine the matter on receipt of the protest in writing together with protest fee as stated in R&R.
- The decision will be made known **1 hour** after the match and decision shall be **FINAL** and no further appeal
- OC has the right to include, amend or exclude any of the terms and conditions
