## LION CITY DANCE CONVENTION 2022 -DANCE SHOWCASE RULES & REGULATIONS

## 1. <u>CATEGORIES</u>

1.1. All participants shall compete in their respective age groups as follows:

Category	Event	
SHOWCASE	<u>Video submission</u> <u>Qualifiers</u> <u>Top 16 to Finals</u>	JUNIOR CATEGORIES (17YRS OLD AND BELOW) OPEN CATEGORIES (18YRS OLD AND ABOVE)

1.2. Each participant can only compete for one (1) team per category.

#### 2. <u>REGISTRATION</u>

2.1. Registration fees apply as follows:

Category	Registration Fee
SHOWCASE	\$15 per dancer Payment upon notification of placing into finals

- 2.2. For each of the Showcase category, each team will have to register all dancers for the competition. Teams will be allowed to edit the roster 1 time but must keep 80% of the dancers.
- 2.3. Registration constitutes representation; that is, once a participant is registered to play for a team, he or she is deemed to have represented their team. Hence, the player cannot represent another team in the same category.
- 2.4. Organizers reserve the right to reject the registration of any player(s) and or any team(s) at their own discretion.
- 2.5. A follow-up email for registration confirmation will be sent after 3-5 working days
- 2.6. A follow-up email with reporting time and details will be sent 3 days after the registration is closed.

## 3. FORMAT OF SHOWCASE QUALIFIERS

The Showcase rules apply to all situations not specifically addressed below.

- 3.1. Each team must have a minimum of 5 members and maximum of 30 members.
- 3.2. Each Team can only sign up under One (1) Showcase categories.
- 3.3. The qualifiers will be done via video submission format.
- 3.4. Front cam 1 take, no editing allowed [To be uploaded by 17 JULY 2359]
- 3.5. Each song duration to be between 3min to 5mins.

#### 4. FORMAT OF SHOWCASE FINALS

The Showcase rules apply to all situations not specifically addressed below.

- 4.1. The TOP 16 teams would be chosen from the video submission from both each category.
- 4.2. Each song duration to be between 3min to 5mins
- 4.3. Stage dimensions are 11m X 7.3m (Subject to changes)
- 4.4. Each team will have an allocated time slot for stage mark that should be followed strictly, there will not be any alternatives given if missed.
- 4.5. Final tracks are to be submitted to Organizers by stipulated dates in the email sent to finalists.(Any <u>explicit languages</u> found in the tracks are subjected to approval by the Organizers.)
- 4.6. Finals Points system
  - Total of 5 judges scoring:
  - Highest and lowest score will be removed
  - Middle 3 scores will be averaged out as the final score

### 5. <u>POSTPONEMENT</u>

5.1. The organisers is at its discretion to decide to postpone the event if it thinks that the venue is unfit for competition or for any other valid reasons for which it deems a postponement is in order. Teams must abide by the decision of the organisers.

### 6. WITHDRAWAL AND WALK-OVER

- 6.1. Any withdrawal or walk-over is considered contrary to the spirit of the game.
- 6.2. Teams participating in the competition should not withdraw or give a walk-over.
- 6.3. For each withdrawal, it is non-refundable.

### 7. <u>PRIZES</u>

- 7.1. Medals and prizes will be awarded to the top 3 teams of each category.
- 7.2. The cash prizes for the competition are as follows:

Placing / Category	Junior	Open
1st Place	\$2,000	\$4,000
2nd Place	\$1,000	\$1,500
3rd Place	\$800	\$1,000

#### 8. <u>DISPUTE MEDIATION</u>

- 8.1. The judge's decision is final.
- 8.2. Competitors are not allowed to interfere with the final decision taken by the judges on points of laws/rules after clarification has been sought. If such interference results in the disruption of the event, the case will be referred to the organisers for appropriate action.
- 8.3. The organisers will have the final decision in all dispute matters.

#### 9. **DISQUALIFICATION**

- 9.1. A team will be disqualified if it commits any of the following:
  - fielding unregistered dancer.

All results involving the team which has been disqualified will be considered null and void.

#### 10. <u>SCHEDULE</u>

10.1. No change is allowed once the schedule has been arranged.

### 11. <u>AMENDMENTS</u>

11.1. The organisers shall have the right to delete, add or amend the rules and regulations laid down herein. The organisers reserve the right to interpret or amend the rules and regulations of the competition at any time.

## 12. <u>HEALTH AND SAFETY</u>

- 12.1. Players are not allowed to share
  - i Water from the same container
  - ii Towels
- 12.2. <u>Outdoor Venue</u> Wearing facemasks outdoors will be optional.
- 12.3. <u>Indoor Venue</u> Facemask must be on at all other times other than during the period of physical activity.
- 12.4. Players who are feeling unwell will not be allowed to attend the event.
