# **TERMS & CONDITIONS**

# Sport Singapore "Together We Play" Lucky Draw Giveaway

### **Acceptance of the Terms & Conditions**

- By entering the "Together We Play" Lucky Draw Giveaway organised by Sport Singapore (hereinafter referred to as the "Giveaway"), you confirm that you have read, understood, and agree to be bound by these Terms and Conditions, including any amendments made to the Terms and Conditions.
- Sport Singapore reserves the right to amend the Terms and Conditions from time to time, and modify, cancel, or suspend the Giveaway at its sole discretion at any time, with or without notice. All decisions by Sport Singapore relating to the Giveaway are final. Sport Singapore is not obliged to provide reasons or entertain any correspondence whatsoever.
- Sport Singapore and its employees, contest administrators and anyone professionally connected with this Giveaway are not eligible to participate in this Giveaway.
- Participants aged 18 and above are eligible to enter the Giveaway and must have a valid email address.
- Sport Singapore reserves the right, at its sole and absolute discretion, not to consider and to exclude or disqualify any Entry, or to forfeit, withhold, withdraw or reclaim any prizes already awarded, where (1) the participant is deemed to be acting in violation of these Terms and Conditions or abusing or tampering with the operation of these Terms and Conditions; (2) the Entry which a participant has submitted contains false or incomplete information; or (3) there are other reasons that Sport Singapore considers at its sole discretion an Entry has been made in any manner inconsistent with these Terms and Conditions or for the Giveaway. In any such event, no explanation shall be provided by Sport Singapore and no appeals in relation to such decision by Sport Singapore shall be entertained.
- In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or other promotional materials or communications relating to the Giveaway, these Terms and Conditions shall prevail.
- The Giveaway and these Terms and Conditions shall be governed by and construed in accordance with the laws of Singapore, and by participating, the participant submits to the exclusive jurisdiction of the Courts of the Republic of Singapore.

### **Giveaway Redemption**

- Recipients will be contacted via email at the email address submitted with their entry. Sport
  Singapore shall not be liable for late, lost, misdirected or unsuccessful efforts to contact and
  notify the recipients.
- In this Giveaway, the item recipients will receive is a \$100 NTUC e-voucher. The \$100 NTUC voucher will be referred to as 'Prize(s)' hereinafter for purposes stated in this Terms & Conditions.
- The Prizes are distributed via a monthly random draw of all participants within the month (calculated as 1st to 28th/30th/31st of the month, whichever is later). There are 50 Prizes to be redeemed, limited to 5 Prizes per month.
- In the event the vouchers are fully redeemed, no correspondence will be entered into.
